ADMINISTRATOR: Garrison Brothers Distillery, at 1827 Hye Albert Rd., Hye, Texas, 78635 (the "Administrator")

ELIGIBILITY: The Sweepstakes is open to residents the following states: Alabama, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin or Wyoming, who are 21 years of age or older as of the Sweepstakes start date ("Entrant"). Each completed and confirmed entry form will generate one (1) Sweepstakes entry during the Sweepstakes Period. All non-winning eligible Entries are added to subsequent winner drawings. **QR Code:** By scanning the QR code displayed on this Sweepstakes promotional materials during the Sweepstakes Period. An Entrant can scan the designated QR code using the camera application of a smartphone with QR Code scanning capabilities or a device with a QR Code scanning application, scan the QR code found on the sweepstakes promotional materials. Upon scanning the designated QR code, an Entrant will be directed to the Sweepstakes entry website. The Entrant will be instructed to complete and submit the Sweepstakes entry form.

The potential Winner will be notified on or around October 01, 2026 at 01:00 pm Pacific Standard Time using the information provided in their

entry. All drawings will be conducted by the Sponsor or Administrator whose decisions are final and binding in all matters relating to this Sweepstakes. The Sponsor or Administrator will randomly select the potential Winner at the drawing. The decisions of Sponsor are final and binding in all matters relating to the Sweepstakes. Odds of winning depend on the number of eligible entries received during the Sweepstakes Period. The winners will be notified by mobile phone, text message, or email and will be required to claim their Prize within five (5) days. If no response is received within the time allotted, one (1) alternate Winner for that prize will be selected. Any alternates selected will also be required to claim their Prize within five (5) days of notification. If no response is received by the alternates, that prize will go unawarded. PRIZE: Grand Prize. One (1) winner will receive a custom-installed TUFF SHED building intended to serve as a "Backyard Bourbon Barn," together with a Garrison Brothers-provided interior finish-out package, as described below.

A. TUFF SHED building. Winner will receive one (1) custom-installed TUFF SHED Premier PRO Series building configured by Sponsors as the Backyard Bourbon Barn concept build, including standard delivery and installation, with an approximate retail value up to \$20,000.00. Building size, style, color, door and window configuration, and other options will be determined by Sponsors in their sole discretion and are not selected by the winner.

B. Garrison Brothers-provided interior finish-out package. Winner will receive a standard interior finish-out package selected by Sponsor in Sponsor's sole discretion and installed by Sponsor's designated contractor at Sponsor's expense. The finish-out package is intended to reflect the "Backyard Bourbon Barn" concept and may include, by way of example, interior wall finish or siding, shelving, a bar structure, and seating. Sponsor will determine the final scope, materials, finishes, and layout based on the building configuration, safety considerations, and contractor availability. Alcoholic beverages are not included as part of the prize. No cash or stipend.

No cash, stipend, gift card, or other substitute or reimbursement will be provided in lieu of the interior finish-out package or any other prize component. If the winner declines the interior finish-out package, that portion of the prize is forfeited and no compensation will be provided.

Winner-requested additions and upgrades. Approximate Retail Value. Total ARV of the Grand Prize is up to \$20,000.00. Actual value may vary based on selected building options and location.

Installation scheduling is subject to contractor availability, weather, and other factors. Sponsors are not responsible for delays.

Alcohol is not a part of any Prize.

DISPUTE RESOLUTION: BY ENTERING THIS SWEEPSTAKES, EACH ENTRANT AGREES THAT, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR RELATED IN ANY WAY TO THE SWEEPSTAKES OR ANY PRIZE AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS, CONSOLIDATED, OR REPRESENTATIVE ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL, OUT-OF-POCKET, THIRD-PARTY COSTS INCURRED (IF ANY), NOT TO EXCEED FIVE DOLLARS (\$5.00), AND IN NO EVENT SHALL AN ENTRANT BE ENTITLED TO RECOVER ATTORNEYS' FEES OR COURT COSTS, EXCEPT AS MAY BE EXPRESSLY PERMITTED BY LAW; (C) UNDER NO CIRCUMSTANCES SHALL ANY ENTRANT BE PERMITTED TO OBTAIN AWARDS FOR, AND EACH ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL, SPECIAL, OR INDIRECT DAMAGES, LOST PROFITS, AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES NOT TO EXCEED FIVE DOLLARS (\$5.00), AND FURTHER WAIVES ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' SOLE AND EXCLUSIVE REMEDY SHALL BE A CLAIM FOR MONEY DAMAGES (IF ANY), AND ENTRANTS IRREVOCABLY WAIVE ANY RIGHT TO SEEK INJUNCTIVE, EQUITABLE, OR OTHER NON-MONETARY RELIEF. SOME JURISDICTIONS DO NOT ALLOW LIMITATIONS OR EXCLUSIONS OF CERTAIN DAMAGES OR LIABILITY, SO THE ABOVE LIMITATIONS AND EXCLUSIONS MAY NOT APPLY TO YOU. IF ANY PROVISION OF THESE OFFICIAL RULES IS DETERMINED TO BE INVALID OR UNENFORCEABLE, SUCH PROVISION SHALL BE SEVERED, AND THE REMAINDER OF THESE OFFICIAL RULES SHALL REMAIN IN FULL FORCE AND EFFECT TO THE MAXIMUM EXTENT PERMITTED BY LAW. SOME JURISDICTIONS DO NOT ALLOW LIMITATIONS ON DAMAGES; IN SUCH JURISDICTIONS, THE LIMITATIONS MAY NOT APPLY.

Entrant, Sponsors, and the Released Parties (each, a "**Party**" and collectively the "**Parties**") each agree to fully and finally settle all disputes pertaining to the Sweepstakes, administration of the Sweepstakes, and/or these Official Rules only through binding arbitration (in each case, a "**Dispute**"); provided, however, (a) Sponsors shall be entitled to seek injunctive or equitable relief in the state and federal courts in or closest to, Hye, Texas and any other court with jurisdiction over the Parties. In arbitration, there is no judge or jury, and review is limited. The

arbitrator's decision and award are final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.

The Parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator in an arbitration administered by the American Arbitration Association ("**AAA**") or any other mutually agreeable arbitration administration service. The arbitration may be conducted in person, through the submission of documents, by phone, or online.

The arbitration shall be commenced and conducted under the Commercial Arbitration Rules of the AAA, and, where appropriate, the AAA's Supplementary Procedures for Consumer Related Disputes ("**AAA Consumer Rules**"), both of which are available at the AAA website: www.adr.org, unless otherwise mutually agreed between the parties. If an in-person hearing is required, except as otherwise required by applicable AAA rules or applicable law, then it will take place in Hye, Texas or other location determined by the Sponsors. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by either Party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the Dispute must be brought in a court of competent jurisdiction in Hye, Texas. Sponsors agrees to pay the administrative and arbitrator's fees to conduct the arbitration (but specifically excluding any travel or other costs of Entrant to attend the arbitration hearing). If for any reason, a Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the state and federal courts located in Hye, Texas and the Parties hereby consent to, and waive all defenses of lack of personal jurisdiction, and forum non conveniens with respect to venue and jurisdiction in such state and federal courts.

In no event shall any Dispute brought by either Party related in any way to the Sweepstakes be commenced more than one (1) year after the cause of action arose. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.

The arbitrator is empowered to resolve the Dispute with the same remedies available in court, however, any relief must be individualized to you and shall not affect any other entrant or claimant. You and each Party also agree that each Party may bring claims against the other in arbitration only in their respective individual capacities and in so doing **YOU WAIVE THE RIGHT TO A TRIAL BY JURY**, to assert or participate in a class action lawsuit or class action arbitration, to assert or participate in a private attorney general lawsuit or private attorney general arbitration, and to assert or participate in any joint or consolidated lawsuit or joint or consolidated arbitration of any kind. If a court decides that applicable law precludes enforcement

of any of this paragraph's limitations as to a particular cause of action, then that cause of action (and only that cause of action) must remain in court and be severed from any arbitration.

MISCELLANEOUS: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
